

Urgent Information of Sebby Sambom Arrest Warrant By PNG & Indonesian Joing Team

I have sent this message to the Chairman of the TPNPB-OPM Diplomatic Council, Mr. Akoubbo Amatus Douw in Brisbane-Australia, please follow.

Nai, If you have time, you can call me. Because there were reports that the Indonesian Military, Indonesian Police, PNG Military and PNG Police were working together to arrest Komnas TPNPB Spokesman Sebby Sambom, and last night, September 19th 2023, I has spoke with Sonny Karobaba in Port Moresby and he reported that it was true, and he was informed by the Head of State Intelligence, but he said that the Head of State Intelligence and other State Officials were not a problem and they know West Papuans are still Fighting for Freedom, but it was just that there were other PNG Soldiers and Police who were suspected of being paid by Indonesia to work hard to arrest Komnas TPNPB Spokesman Sebby Sambom, and deport him to Indonesia, and in the report Sonny Karobaba said that they had distributed photos of Mr. Sebby Sambom in all places, including Immigration and the Airport.

Noted:

And those Police and Military Team are suspected of receiving bribes money from Indonesian Authority to Arrest TPNPB Spokesman Mr. Sebby Sambom and deport him to Indonesia. If this arrest is made, then the PNG Police and Military Team will sell their own brother to the enemy to be killed. And this is exactly the same and this is no different from what the disciple of the Lord Jesus (Judas Iskarior), who sold the Lord Jesus for a piece of silver coins money (according to God's Words in the Bible).

Therefore please monitor. This is urgent information from Komnas TPNPB spokesperson Sebby Sambom, and thank you for your attention and good cooperation.

This information is important for all parties who care about humanity to know, and this information should not be publishing on social media. And we hope that this information can be conveyed to our State Leaders in PNG who support the Papuan Nation's struggle in West Papua, namely (Governor Powe Parskop and his Team), as well as to Opposition Leaders such as Brother Belde Nama.

The reason for the arrest warrant is according to the information provided by Brother Sonny Karobaba below,

Good afternoon bro, is there a contact for Sebby Sambom? If there is, please advise him, because there is already a team consisting of PNG police and soldiers plus Indonesian soldiers and Intel who are looking for him to arrest him.

The reason; HE,

1. USING THE PNG REGION AND DOING THE COMMAND
2. ORDER THE TPN TO ATTACK OTHER WEST PAPUAN PEOPLE.
3. OTHER ILLEGAL ACTIVITIES.

PLEASE DO CONTACT, ASAP.

Seeing the reasons for this arrest, Sebby Sambom objected and refused because these 3 points cannot be used as justification for arresting Sebby Sambom. And I don't do these 3 reasons in the PNG region, but to be honest, I'm only carrying out the task of informing what is happening in Papua, and that is the function of information so that there must be balanced reporting, meaning it is not one-sided.

So I'm not a journalist, but I am a source that all journalists around the world need. And also I don't carry out commands from the PNG region, but all commands are in West Papua. My job is only to continue statements and reports from West Papua to all parties throughout the world, and especially to all journalists from various media throughout the world.

And I also do not carry out illegal activities in the PNG Legal Territory, because I am in PNG as a Political Asylum Seeker along with other Papuans. And I know that in 2015 the PNG Government has made legal regulations for the protection of all indigenous Papuans who have fled to PNG due to crimes by the Indonesian Military and Police in West Papua, so I am also part of the Political Asylum seekers.

And the PNG Government as a UN member state has obligation and moral burden to protect all Indigenous Papuans seeking Political Asylum. Because I am a former political prisoner, in this case the Indonesian government arrested me 6 times and imprisoned me twice, every year they arrested me when I was in Papua.

And after that Indonesia targeted to kill me, so I and my family fled to PNG and were accepted by the Wewak Diocese Catholic Mission under the Coordination of Francis Kemaken, and Francis Kemaken once reported to the UN Refugee Office (UNHCR) in Port Moresby in 2023, but The UN office said that there was no budget to take care of us, so we lived in Sepik under the protection of the Catholic Church and also with our brothers and sisters in Sepik.

Therefore, these three points of reason for arresting me cannot be justified by customary law and international law. Because we are one land and one nation, if there is a customary law problem we have to sit together and talk as Melanesian people, not accept bribes from Indonesia's colonial enemies and carry out evil plans to arrest humanitarian activists like Sebby Sambom.

Freedom Fighters are people who are willing to do humanitarian work for the liberation of their people and country, therefore Freedom Fighters are respected by the international community. In this way, the PNG Government does not need to make the fatal mistake of arresting freedom fighters at the request of Indonesia with political bribes.

CITIZENSHIP FOR WEST PAPUAN REFUGEES MATTERS

West Papuan refugees have lived alongside us for almost 50 years. Until recently they have held an informal status. The Government of PNG has launched a nationwide project to provide West Papuan refugees the opportunity to become PNG citizens.

Papua New Guineans are rightly proud of our tradition of welcoming and offering a helping hand to Melanesian refugees.

All refugees who become PNG citizens share all of the same rights and responsibilities as other Papua New Guineans.


Under the first ever Naturalisation and Registration Project for West Papuan refugees, the Government is offering citizenship to West Papuan refugees living in the country, who meet the requirements for naturalisation that are outlined in PNG's Constitution.

The Government has waived the 10,000 Kina citizenship application fee for refugees.

Those who do not seek citizenship, will be eligible to obtain refugee visas and passports after completion of the process.

This project is providing West Papuan refugees with certainty and a secure future for the first time.
